House Appropriations Update

If you blinked you missed it. Last week, the House Labor, Health and Human Services and Education Appropriations Subcommittee posted a notice indicating that the committee would in fact release and mark up their version of the FY 2014 appropriation bill. Almost 48 hours later, the hearing was postponed due to "scheduling" issues. Many DC advocates speculate that the House does not want to release this bill because the cuts will be so devastating and it is easier for Representatives to discuss the cuts from a theoretical perspective. The Coalition for Health Funding is leading advocacy efforts urging the House to mark up this bill and sent a [letter](#) to House appropriators last week. AMCHP continues to closely monitor these developments and will keep you updated as this unfolds.

ACA Update

On Jul. 26, AMCHP signed on to a [letter](#) to Sec. Sebelius along with various other maternal and child health (MCH) organizations in support of clarifying regulations regarding maternity coverage for adult children under the health plans of their parents up to age 26. Currently, offspring of dependent children is not included in this provision.

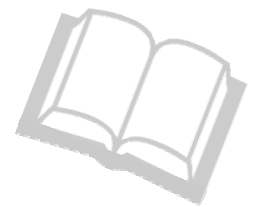
Webinar Series: Leading in Changing Times

Alaska Maternal and Child Health Data Book 2012: Birth Defects Surveillance Edition

The Alaska Division of Public Health is pleased to announce the release of their new data book, the sixth in a series of comprehensive reference books on the status of women's, infant's and children's health in Alaska. Readers are encouraged to use the data presented in this book to improve the health of Alaska's children. This is the second comprehensive analysis of the Alaska Birth Defects Registry data. This data book provides a detailed descriptive epidemiology of the prevalence and distribution of major congenital anomalies among Alaskan populations. It is divided into chapters based on the anatomical site of the malformation. Analysis includes temporal trends, geographic distributions, and epidemiological characteristics. Family Caregivers of Children with Special Health Care Needs: the Need for Caregiver Support as Truly Family-Centered Care Fact Sheet

According to a 2009 report by the National Alliance for Caregiving, there are 16.8 million unpaid family caregivers of children and youth with special health care needs (CYSHCN) in the U.S. As health care costs rise, CYSHCN are increasingly dependent on home-based family caregivers to meet their formal health care needs. Despite this, family caregivers do not receive the training or ongoing support they need from health care systems. Family caregivers provide invaluable, life sustaining services for the CYSHCN, however their importance is often not recognized and overlooked. Created by Jess Nelson, 2012-2013 MN LEND Fellow and Donna Yadrich, Patient/Family Advocate & 2012-2013 AMCHP Family Scholar, this fact sheet provides background information detailing the emotional, physical and financial costs to CYSHCN family caregivers and the need for an available support system, personal

PRAMS Releases CPONDER 2.0

The Pregnancy Risk Assessment Monitoring System (PRAMS) team is pleased to announce the release of the new CPONDER Version 2.0 system. CPONDER contains prevalence and trends data for more than 190 indicators from the PRAMS survey from 2000 through 2010 and the 2009-2010 flu survey supplement. PRAMS is a state, population based surveillance system of women who recently delivered a live-born infant, and collects information on mothers behaviors and experiences before, during, and after pregnancy. PRAMS provides ongoing, high-quality maternal and infant health data that can be used for planning programs and informing policies. To access CPONDER, [click here](#).

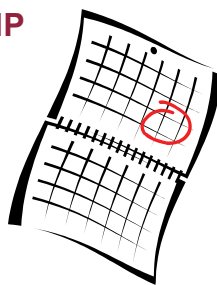


AMCHP Working on Your Behalf

- On Jul. 24, AMCHP hosted “*Connecting the Dots: A National Meeting on Improving Birth Outcomes Initiatives*” in Washington, DC. In attendance were leaders from various state MCH and Medicaid programs, federal agencies, professional associations and foundations. The objectives of the meeting were to briefly review and discuss key national and federal initiatives designed to improve birth outcomes, identify areas of connectivity, commonality and gaps in focus and goals, discuss and prioritize areas needing improved coordination to optimize and maximize collective impact at the federal, state and local levels, and, solidify the core elements of a common national framework, and collective strategies for advancing mutual goals. Proceedings from the meeting will be disseminated in the weeks to come, so stay tuned! This meeting was hosted with generous support from the W.K. Kellogg Foundation.
