AMCHP Hill Day Recap and Next Steps

Thank you to everyone who participated in our Hill Day and Congressional Reception in conjunction with the AMCHP annual conference! We were honored to be joined by five senators and representatives, most notably our honorees Sens. Grassley (R-IA) and Menendez (D-NJ). We've gotten some great feedback and welcome your suggestions on how we can improve our Hill days in the future. President's FY 2016 Budget Released

On Feb. 2, Pres. Obama released his FY 2016 budget. In case you missed it, [here](#) is the AMCHP legislative alert highlighting some key programs including a proposal to level fund the Title V MCH Services Block Grant at \$637 million. The next step is for Congress to release its own budget resolution and subsequent appropriations bills, though that process is likely to take several months. In the meantime, AMCHP will begin a series of staff meetings sharing our request of \$639 million for Title V with key Appropriations Committee members and other potential MCH champions. Stay tuned for future alerts on how you can make sure your voice is part of this process.

ACE Kids Act Reintroduced

The Advancing Care for Exceptional (ACE) Kids Act of 2015 (HR 546/S 298) was reintroduced in late January in both the House and the Senate. This legislation aims to improve care coordination for children with medical complexity on Medicaid by creating coordinated care networks across state lines anchored in children's hospitals. The bill also proposes a new risk-based payment method to be managed by the networks that would align reimbursements with best outcomes. AMCHP is working with the proponents of the bill to better understand its implications and to address some concerns that have previously been raised by our members. Moving forward, we plan to offer opportunities to learn more about this legislation and welcome further input from you.

Health Reform Implementation

Open Enrollment

According to the U.S. Department of Health and Human Services (HHS), 9.5 million consumers are signed up for health insurance through the Marketplace. Continue being a champion for open enrollment! Open enrollment runs through Feb. 15. The Robert Wood Johnson Foundation (RWJF) has developed a research-based, consumer-focused website to help direct individuals and families to health care coverage options. 2014 Annual Report on the Quality of Care for Children in Medicaid and CHIP

HHS released their [annual report](#) exploring several domains and activities in efforts of achieving a high quality system of care for children enrolled in Medicaid and the Children's Health Insurance Program (CHIP). The 2014 Secretary's Report presents information on key activities CMS undertook to provide an update on the quality of care children receive in Medicaid/CHIP, including reviewing findings on the Child Core Set and summarizing information on managed care quality measurement and improvement efforts reported in the External Quality Review (EQR) technical reports.

Breastfeeding Support

Dr. Nancy Lee, Director at the Office of Women's Health, wrote a helpful [blog post](#) on tips to support nursing moms and introduced a new [website](#) on breastfeeding and employer solutions. This website has lots of helpful information and resources. The ACA requires many employers to provide reasonable break time and a private (non-bathroom) space for nursing mothers to express breast milk during the workday for up to one year after the child's birth and requires qualified health insurance plans to cover breastfeeding pump rental or purchase at low to no-cost sharing. AMCHP developed an [issue brief](#) highlighting state opportunities and strategies for breastfeeding promotion through the ACA.

New Reports on Loss of CHIP Coverage

Two new reports focus on children in Arizona who lost CHIP coverage. The reports focused on the impacts of the cuts on families and lessons learned for the future. The reports, *Children's Health Coverage in Arizona: A Cautionary Tale for the Future of the CHIP*, and *Living Without KidsCare Insights from Parents of Children Who Lost Their Health Coverage When Arizona Scaled Back Its Children's Health Insurance Program* can be accessed [here](#).

Indiana Medicaid Expansion

Indiana has joined 27 states and the District of Columbia in expanding Medicaid under the ACA. The expansion could bring coverage to approximately 350,000 uninsured individuals in the state. Enrollment began immediately after federal approval of the expansion plan for coverage beginning Feb. 1. The approved plan includes two levels of plans for the newly eligible population, both include some premium cost to the insured, the minimum is one dollar. Additionally, there are consequences for those who miss premium payments: for those above 100 percent of the federal poverty level (FPL) there is a six month lock out period and for those below 100 percent FPL, there may be a demotion in plan benefits such as loss of vision or dental services.

The National MCH Workforce Development Center offers a range of trainings, tools and resources to strengthen MCH workforce capacity to lead through health transformation. The Center offers training in four key areas: access to care, quality improvement, systems integration and change management. State/territory Title V agencies/MCH programs and their partners will have the opportunity to gain knowledge, skills, and tools in the four key areas and apply them to a current health transformation project of interest. Cohort 2 participants should plan to be actively engaged with the Center from April through December 2015. All applications must be received by Feb. 27 at 5 p.m. EST. Call for Applications: Training Course in Maternal and Child Health Epidemiology

The Maternal and Child Health Bureau (MCHB), CDC and CityMatCH are offering a Training Course in MCH Epidemiology on Jun. 1-5 in Baltimore, MD, as part of their ongoing effort to enhance the analytic capacity of state and local health agencies. The training course is an intensive program, combining lectures, discussion, hands-on exercises and opportunities for individualized technical assistance. Content for the 2015 course will include: needs assessment; target setting for performance measurement; program evaluation; statistical and epidemiologic methods: from descriptive statistics to multivariable modeling; and presenting data: linking high quality analysis to reporting. A brief series of webinars prior to the training will set the stage for the onsite training. This national program is aimed primarily at professionals in state and local health agencies who have significant responsibility for collecting, processing, analyzing and reporting MCH data. This year, the course is geared to individuals with basic to intermediate skills in statistical and epidemiologic methods, preferably in MCH or a related field. 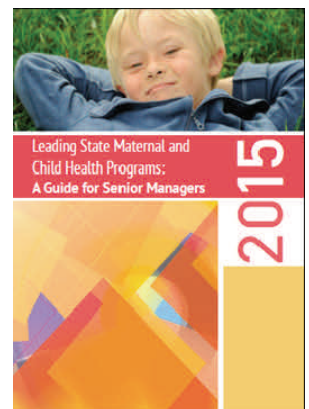

The webinar also provided state-in-action examples from Oregon, Wisconsin and Wyoming about their strategies for stakeholder engagements, such as how to engage your local nonprofit hospitals and use its community health assessment to contribute to the needs assessment process that is now mandated by the ACA.

The indicators' intended use is to guide assessment and surveillance and affect public health interventions to disaster-affected pregnant and postpartum women and infants. NIH Patient Safety in the Context of Perinatal, Neonatal and Pediatric Care

Deadlines: *Mar. 5 (R01) and Mar. 16 (R21, R03)*

A wide range of collaborative research projects related to patient safety in the context of perinatal, neonatal and pediatric care both in routine hospital settings and in the intensive care units related to:

Areas of interest also include studies to inform counseling and strategies for addressing barriers to prenatal care, and management of pregnancy, the puerperium, and the transition to parenthood in order to optimize outcomes for women with physical, intellectual and developmental, and/or sensory disabilities and their families. NIH Studies in Neonatal and Pediatric Resuscitation

Deadlines: *Mar. 5 (R01)* and *Mar. 16 (R21, R03)*

Grant applications should propose to stimulate research on a wide range of topics related to neonatal and pediatric resuscitation. It is anticipated that the results from well-conducted studies will enable translation of knowledge into evidence-based resuscitation practices ensuring optimal short- and long-term outcomes for all newborn infants and children. Letters of intent are due 30 days before application due dates. CDC Research Grants for Preventing Violence and Violence Related Injury

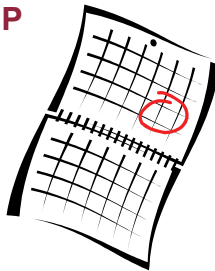
