MANAGEMENT MINUTE



Listening

An attribute of leadership that gets short shrift is listening. Far too often, leadership involves talking (communication is the 10th Absolute I wrote about last month). Leaders are on podiums giving speeches,

on television or radio doing interviews, on e-mail writing and opining about their cause, their organization, their leadership. Rarely do we see pictures of a leader listening – and yet effective leaders focused on both listening and speaking. In fact, Burnison argues, the most effective leader will listen 80 percent of the time and talk just 20 percent. How else is a leader gathering information to set the vision of their organization, how else does a leader know what is going on in their environment? How else do coworkers and colleagues feel valued and part of a team? A leader must listen and yet we rarely prioritize “listening” time in our day-to-day activities.

We have all worked with leaders who do a lot of talking and a little listening. We don't feel valued, we feel as if our contributions literally fall on “deaf ears.” We shut down, tune out, put our energy elsewhere. What a waste! A leader who listens is actively engaged in leading – gaining input to set their organization's course, hearing both positive and negative opinions of their strategies and tactics. Listening and learning go hand and hand – we must listen to learn, and we must learn to lead. Listening takes courage – admitting that you might not have all the answers or the definitive opinion on an issue or topic but instead are open to

hearing others, and integrating that information in to your own work as a leader.

In Burnison's chapter on listening, he cites Winston Churchill who said: “[C]ourage is what it takes to stand up and speak; courage is also what it takes to sit down and listen.” As leaders, I urge us to be courageous listeners then – devote the time and energy to listening and learning from those with whom we work, partners, colleagues and, yes, even those with whom we disagree. It is through listening that we clarify and understand the needs and positions of others. As maternal and child health (MCH) leaders, we have begun to take seriously the challenge of listening to families and consumers involved in our work. Have you listened to the stories told by families served in your state? I am in constant awe of the stories family leaders share and the way that their lives shape strategies for AMCHP. If we didn't listen to their stories, our work would be less effective and less useful to those we serve. Only through listening can we truly move our organizations forward – and lead.

This time of year it is hard to listen. There is so much “noise” all around us it can seem impossible to focus and devote oneself to listening. And yet we must do precisely that – take time to listen. Challenge yourself to actively listen. Let me know what you are hearing – I'm listening too!

Oklahoma Infant Alliance Late Preterm Infant Toolkit Webinar

MCHB Accepting Applications for GSEP Program

MCHB sponsors the Graduate Student Epidemiology Program (GSEP), formerly known as GSIP, with the goal of enhancing students' skills in data analysis, encourage training in MCH epidemiology, and providing assistance to state and local health agencies with data-related projects. MCHB will support up to 20 students in state-level MCH/CSHCN agencies and 10 in city and county MCH departments. These projects will be conducted primarily during the summer of 2013 (beginning in May, June or July). Eligible students are those currently enrolled in schools of public health who have successfully completed coursework in epidemiology, biostatistics, and health administration, and who are specializing in the MCH study. New MMWR Touches on Tobacco Use and Reproductive Health

The Nov. 2 issue of the *Morbidity and Mortality Weekly Report* (MMWR) touches on two important MCH issues, tobacco use and reproductive health. *Current Tobacco Use and Secondhand Smoke Exposure (SHS) among Women of Reproductive Age – 14 Countries, 2008-2010* focuses on several low- and medium-income countries participating in the Global Adult Tobacco Survey. The authors suggest levels of exposure of pregnant women to in many countries are sufficient to threaten the health of their unborn children. *Assisted Reproductive Health Technology Surveillance, US, 2009* presents data on ART use and birth outcomes for U.S. states and territories. The authors analyzed data from the CDC National ART Surveillance System (NASS) to report on ART use and ART-related perinatal outcomes. To view the issue, [click here](#).

New Article on Developing a Standard Approach to Infant Mortality Examination

States can improve pregnancy outcomes by using a standard approach to assess infant mortality. The State Infant Mortality Collaborative (SIMC) developed a series of analyses to describe infant mortality in states, identify contributing factors to infant death, and develop the evidence base for implementing new or modifying existing programs and policies addressing infant mortality. The SIMC was conducted between 2004 and 2006 among five states: Delaware, Hawaii, Louisiana, Missouri and North Carolina. States used analytic strategies in an iterative process to investigate contributors to infant mortality. [Click here](#) to read the full article.

MMWR Publishes Study on Newborn Screening for Critical Congenital Heart Disease

The CDC and the National Birth Defects Prevention Network have published a study in the *MMWR* titled "Newborn Screening for Critical Congenital Heart Disease (CCHD): Potential Roles of Birth Defects

Surveillance Programs – United States, 2010-2011." CDC worked with the National Birth Defects Prevention Network to assess how state birth defects tracking programs could assist with CCHD screening. States were surveyed in November 2010 after the initial recommendation and again in November 2011 after the approval of the Secretary. The purpose of the surveys was to assess the potential roles of the program, capabilities and readiness to assist with newborn screening activities for CCHD. To view key findings, [click here](#). HRSA Preventive Medicine and Public Health Training Grant

Deadline: *Nov. 28*

The purpose of the Preventive Medicine and Public Health Training Grant Program is to increase the number of preventive medicine physicians and promote greater access to population-based healthcare. The funding may be used to support resident costs, infrastructure and faculty development activities. At least 75 percent of the funds must be used for trainee support, such as tuition for the master's degree in public health or other master's degree related to the preventive medicine specialty, fees, travel, and stipends (reasonable living expenses). HRSA Social and Behavioral Interventions to Increase Solid Organ Donation Grant

Deadline: *Nov. 30*

The overall goal of this grant program is to: 1) reduce the gap between the demand for organ transplants and the supply of organs from deceased donors by identifying successful strategies that can serve as model interventions to increase deceased organ donation and, 2) increase the knowledge of options available through living donation among patients who may need transplants and/or individuals considering serving as a living donor. Accordingly, this program will support sound applied research efforts to test the effectiveness of strategies that target any of the three program objectives listed below. The first two objectives pertain to deceased donation; the third relates to living donation. The specific objectives of this grant program are to increase, and improve understanding of how to increase: 1) individual commitment to be a deceased organ donor and documentation of that commitment; 2) consent of family (or others authorized to consent) for organ donation for a deceased relative; 3) the knowledge of the process, risks, advantages and disadvantages of deceased and living donation among patients who may need an organ and/or individuals considering serving as a living donor. 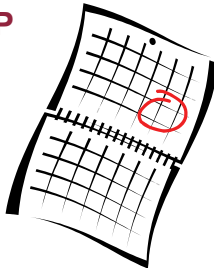
